IS A TRUST RIGHT FOR ME?

- An individual with a disability has too many assets to remain eligible for government benefits.
- An individual with a disability receives a financial settlement or inheritance that would affect his or her eligibility to receive essential government benefits.

Third Party Trust

Marie

BACKGROUND

Marie, a 48-year-old woman with an intellectual disability, was living with her mother, Jeanne. Marie enjoyed socializing with her friends and her dog, Ace, that her mother had given her. Jeanne wanted her daughter's future to be protected, so she contacted ACHIEVA Family Trust for help.

WHY A SPECIAL NEEDS TRUST?

Jeanne worked with a local elder law attorney and established a Third Party Special Needs Trust as part of her will one year before she passed away suddenly. Following Jeanne's passing, ACHIEVA Family Trust was able to secure temporary housing for Marie until permanent housing could be arranged.

RESOLUTION

Her mother's wish for Marie to lead a fulfilling life was realized. By establishing the special needs trust, Marie's mother could safely leave assets in her estate to her only daughter, without jeopardizing her eligibility for government benefits. Marie's transition from sudden loss to new life opportunities was seamless, and she now has funds available to travel and pursue her interests.

What Is a Special Needs Trust?



A SPECIAL NEEDS TRUST HELPS
PROTECT THE ASSETS OF A PERSON
WITH A DISABILITY. It allows the beneficiary,
or the individual receiving the benefits, to make
critical, life-enhancing purchases, like medical care,
clothing and transportation.

GOVERNMENT BENEFITS HELP INDIVIDUALS WITH DISABILITIES AND THEIR FAMILIES PAY FOR SPECIFIC

NEEDS. These benefits include Medical Assistance, Medicaid Waivers and Supplemental Security Income (SSI), Social Security Disability and Medicare.



HOWEVER, IF A PERSON HAS MORE THAN \$2,000 IN ASSETS, THEY CANNOT ACCESS THESE GOVERNMENT BENEFITS.

A special needs trust allows people to exceed the \$2,000 asset limit, access government benefits and supplement those benefits with their trust funds.

Types of Trusts

ACHIEVA Family Trust offers three types of low-fee trusts to protect and enhance quality of life for individuals with disabilities.

The beneficiary, their parent, grandparent, legal guardian or the court can establish this trust.

POOLED TRUST

ACHIEVA Family Trust operates the largest Pooled Trust in Pennsylvania and also serves several other states. The assets of all the beneficiaries in a Pooled Trust are combined (or "pooled") for investment purposes. The trustee still separately accounts for each person's interest. Trust accounts can be established quickly and at little or no cost. Any remaining funds, when the beneficiary passes away, are placed in a Charitable Residual Account that benefits individuals with disabilities.

Any beneficiary under 65, their parent, grandparent, legal guardian or the court can establish this trust.

PAYBACK TRUST

Individuals with a disability who are receiving funds in their name, particularly as a result of a personal injury or a malpractice settlement, can benefit from a Payback Trust. It enables them to utilize the funds in their trust to pay for expenses that are not covered by government benefits. These include home modifications, adapted vehicles and specialized treatments or medications. The beneficiary continues to qualify for their government benefits, but upon the death of the beneficiary, any funds remaining must be used to "pay back" the state(s) for Medicaid Services received. Following this payback, remaining funds are distributed to other individuals and/or organizations according to the trust document.

Anyone can fund this trust during their lifetime and/or through their estate plans for a beneficiary of any age.

THIRD PARTY TRUST

With a Third Party Trust, friends and family of an individual with a disability can provide for their loved one while still preserving the individual's eligibility for essential, lifelong supports and services. Funds remaining at the death of the beneficiary are distributed according to the trust document to other individuals and/or organizations.

This account provides supplemental supports and services for children and adults with disabilities.

CHARITABLE RESIDUAL ACCOUNT

Some families lack the resources to access critical supports and services. We are proud to assist through the Charitable Residual Account. When the beneficiary has passed, any existing Pooled Trust funds become part of this account used to benefit individuals with disabilities. Since 2005, we have been able to provide more than \$4,000,000 in goods and services to people in need with disabilities.

Payback Trust

Taylor

BACKGROUND

Taylor is a lively 12-year-old girl who loves to have fun with her siblings. She has severe, lifelong physical and cognitive impairments because of an injury at birth. Her parents didn't know if their child would ever have the opportunities other children have. Her family worked with a local malpractice attorney, and Taylor was awarded medical malpractice settlement funds that were placed in a Payback Special Needs Trust for her benefit with the help of ACHIEVA Family Trust.

WHY A SPECIAL NEEDS TRUST?

Taylor has had several surgeries, and needs a wheelchair and other special equipment. Without the special needs trust, the funds from Taylor's settlement would disqualify her for government support.

RESOLUTION

Trust administrators helped the family use trust funds to make major modifications to the family home that benefitted Taylor. They also purchased an accessible van, a bed designed for children with severe physical impairments and other specially adapted equipment that would not be covered by government funds.

Pooled Trust

Jackson

BACKGROUND

Jackson is a 33-year-old man with an intellectual disability, living with his mother and working a part-time job. His father passed away unexpectedly without a plan in place for the funds that he wanted to leave for Jackson. The funds from his father's estate, and a small retirement savings that Jackson had from his work, made him ineligible for important government benefits that would enable him to receive services while living with his mother and in the future.

WHY A SPECIAL NEEDS TRUST?

Jackson and his mother contacted ACHIEVA Family Trust to set up a Pooled Trust for Jackson's benefit. The funds in Jackson's name were placed in a Pooled Trust, and immediately, he was able to apply for a Medicaid Waiver funding for services.

RESOLUTION

Through the Medicaid Waiver, Jackson receives companion services that allow him to participate in community activities, and will ensure that residential supports are available to Jackson in the future. With his Pooled Trust funds, Jackson is able to go to baseball games, pay for medical needs and live with the peace of mind that his future is protected.
